\_\_\_\_\_Should any changes occur to the terms and conditions of this membership, Tummy Temple will send a notice of change to the email address on file at least ten days prior to the effective date of such change. Should prices increase, Member has the right to cancel membership without penalty during initial period following cancellation guidelines as described below.

## CANCELLATION POLICY

### CANCELLING YOUR APPOINTMENT:

\_\_\_\_\_Member may cancel an appointment without charge in advance of 24 hours before the appointment start time. **Same-day cancellations or not showing up for the monthly appointment will result in forfeiture of that month's Membership service.**

**CANCELLATION OF MEMBERSHIP DURING INITIAL SIX-MONTH TERM:** Member may cancel this agreement during the initial six-month term of the membership upon the following conditions:

- ❖ Member death or permanent physical disability.
- ❖ A physician's note certifying that Member is unable to receive services.
- ❖ Tummy Temple increases the cost of membership.

## CANCELLATION OF MEMBERSHIP DURING AUTO RENEW TERM

Tummy Temple reserves the right to terminate or deny re-enrollment for an indeterminate amount of time if Member has an unsatisfactory payment history.

\_\_\_\_\_ If Member's payment account has insufficient funds to complete the transaction, or payment account or credit card does not otherwise permit the transaction to be executed, a \$25 insufficient funds fee will be charged.
